- Exemptions will be granted only for **members registered with the IBSL**. IBSL is not able to confirm your eligibility for exemptions until you have fully registered as a member.
- Closing date for application for exemption for March 2011 CBF / DBF Examination is **1<sup>st</sup> December 2010**.

Closing date for late applications for exemptions for March 2011 examination is **15<sup>th</sup> December 2010** (subject to 50% surcharge)

- Candidates should produce their original certificates of the qualifications for perusal and return. Applications without documentary evidence will not be considered.** In the event of candidates inability to produce original certificates, valid reasons must be given and photocopies may be produced attested with rubber stamp by the employer.
- University Degrees or full professional qualifications in Accounting, Marketing, Banking and Finance, Economics, Management, with related subjects from a recognized University or any other professional body acceptable to the Institute are considered for total exemption from CBF. (Please refer rule 7(a) (i) & (ii) of the IBSL Regulations & Syllabi)
- University Degrees or full professional qualifications in Accounting, Management, Banking and Finance, Economics, and Information Technology are considered for DBF maximum one subject exemption. University Postgraduate Degree holders' from the above fields are considered for maximum two subject exemptions.
