To register as a student member of the IBSL to sit IABF, the following requirements should be complied with.

- i. An employee of the licensed bank or any financial institution licensed or approved by a state authority in Sri Lanka or abroad under any Statute or
- ii. An employee of a company incorporated under the Companies Act or any institution established under any Statute or regulation in Sri Lanka or abroad or
- iii. A graduate or an undergraduate of a recognized university in Sri Lanka or abroad or
- iv. Final qualification offered by a professional institute in Sri Lanka or abroad on banking, finance, audit, management and marketing or
- v. GCE (A/L) or equivalent examination in Sri Lanka or abroad having (3) three passes with (2) two credit passes in Mathematics in GCE (O/L) or equivalent examination in Sri Lanka or abroad or
- vi. GCE (A/L) or equivalent examination in Sri Lanka or abroad with (2) two passes and GCE(O/L) or equivalent examination in Sri Lanka or abroad having (6) six passes at two sittings with (5) five credit passes including Mathematics or
- vii. GCE (O/L) or equivalent examination in Sri Lanka or abroad with (6) six passes at one sitting having (5) five credit passes including Mathematics.
